

Appropriate Body service

We will:

- Register the Early Career Teacher (ECT) on the Teacher Regulation Agency (TRA) system.
- Where schools also opt for the Early Career Framework (ECF) Full Induction Programme with Bradford Teaching School Hub, provide a seamless ECF/AB service and experience.
- Where required, undertake fidelity and induction checks of the Early Career Framework-based programme in line with the statutory guidance.
- Ensure ECTs fairly and regularly assessed through collection of monitoring reports and formal assessment points at the end of year 1 and 2 of induction.
- Provide telephone support to Induction Leads and ECTs.
- Facilitate additional support for ECTs not meeting Teacher/Induction Standards

Charges – all prices are subject to VAT where applicable

Charges for each term will be calculated as follows:

Option 1 (recommended): A school accessing both the fully funded by <u>DfE Early Career Framework (ECF) Full Induction Programme (FIP)</u> and the appropriate body service via Bradford Teaching School Hub and Ambition Institute

- The price of this service reflects the reduced administrative and workload burden on both the school and the Hub as no fidelity checking and induction checks of the ECFbased induction are required as part of the Appropriate Body (AB) service. Bradford Teaching School Hub will have access to engagement data as the ECF delivery partner.
- Bradford Teaching School Hub is in a unique position of being both an ECF delivery partner and an AB.
- £40 per ECT per term / £120 per year / £240 per full induction

Option 2: A school accessing the Early Career Framework Full Induction Programme via another provider and the appropriate body service via Bradford Teaching School Hub

- In-line with the statutory guidance, induction checks of the ECF-based induction are required as part of the appropriate body service. Induction Leads will need to facilitate these checks.
- £50 per ECT per term / £150 per year / £300 per full induction

Option 3: A school accessing the Early Career Framework Core Induction Programme (CIP) and the appropriate body service via Bradford Teaching School Hub

- In line with the statutory guidance, fidelity checking and induction checks of the ECFbased induction on at least three occasions are required as part of the appropriate body service. The Induction Lead will need to facilitate the fidelity and induction checks.
- £55 per ECT per term / £165 per year / £330 per full induction

Option 4: A school designing and delivering their own two-year induction programme based on the Early Career Framework and the appropriate body service via Bradford Teaching School Hub. The Induction Lead will need to facilitate the rigorous fidelity and induction checks.

- In line with the statutory guidance, fidelity checking and induction checks of the ECFbased induction on at least three occasions are required as part of the appropriate body service.
- £100 per ECT per term / £300 per year / £600 per full induction

Options 2-4: There may be additional charges for schools require support as a result of have non-compliant ECF programmes.

Additional support can be commissioned from the Hub.

Bradford Teaching School Hub uses NQT Manager to register all ECTs and gather assessment forms for the same. This is an online system created and managed by Evolution.

In agreeing to use Bradford Teaching School Hub as the Appropriate Body, schools agree to permit the sharing of data with Evolution and NQT Manager such as is necessary for the completion of registrations and assessments and not for any other purpose outside that of ECT Induction and the associated statutory requirements.

Schools also agree to the sharing of assessment forms, when ECTs move to new schools, with other schools/Appropriate Bodies as required, in line with statutory guidance.
